Dossier: Sheikh Abdullah bin Zayed Al Nahyan (UAE Foreign Minister)

Jurisdiction hook: Crimes consummated on State of Palestine territory (ICC jurisdiction per Pre-Trial Chamber 5 Feb 2021). Assistance outside the territory that has a substantial effect on crimes inside it may be charged as accessorial liability (Art. 12(2)(a)).

May 20, 2025	Publicly agreed with Israel's FM on Gaza aid arrangements, keeping diplomatic channel active.
